PROPOSED AMENDMENTS TO THE LANDMARK PARENT TEACHER ASSOCIATION CONSTITUTION

5. Executive

5.1. The PTA executive shall consist of 10 members: the principal from each school, a teacher representative from each school, and three parents representing each school – Landmark Collegiate and Landmark Elementary School.

The PTA shall consist of up to 10 members: the principal from each school, a teacher representative from each school, and 4-6 parents. Every effort will be made to have equal representation from each school.

5.2. Election and Terms of Office:

5.2.1. Three parents shall be elected to the executive each year for a two-year term at the last general PTA meeting of each school year. This ensures overlapping continuity for the executive.

Parents shall be elected to the executive each year for a two-year term at the PTA Annual General meeting of each school year. This ensures overlapping continuity for the executive.

5.2.2. Nominations shall be called for two weeks prior to the last general PTA meeting of the school year.

Nominations shall be called for two weeks prior to the PTA Annual General Meeting.

5.3. Officers:

5.3.1. Executive Officers shall be elected by the executive at the first executive meeting after the election of new members in the spring of each school year.

Executive Officers shall be elected by the executive at the first executive meeting after the election of new members in the fall of each school year.

5.3.4.5. The Social Convener ensures coffee/refreshments are available at general PTA meetings.

The Social Media Manager manages any PTA social media pages and is responsible for posting pertinent PTA info such as the date of the PTA Annual General Meeting, fundraising reminders, and other events.

7. Meetings

7.2. The executive shall meet every other month for the duration of the school year, beginning in September.

Executive meetings will take place every other month for the duration of the school year, beginning in September. These meetings will be open to PTA Executive members only. In the event that a parent who is not on the executive should wish to attend to discuss a specific issue, they must submit a request in writing at least 7 days in advance of the next PTA executive meeting to be placed on the agenda. Alternatively, the parent may choose a member of the executive to bring their concerns forward at the next executive meeting.

7.3. The PTA executive will publish a newsletter in September informing parents of all general meetings and executive meetings.

The PTA executive will publish a newsletter in June informing parents of the Annual General Meeting and executive meetings.

8. Amendments

8.2. Proposed amendments must be distributed in writing a minimum of 30 days in advance of the spring general meeting.

8.4. For an amendment to be accepted, it must pass with a simple majority vote at the spring PTA general meeting.
